Recovery-Series and UEB 8.2.0-x Release Notes

This document describes features and resolved issues in the 8.2.0-x releases.

Release 8.2.0-8

The 8.2.0-8 release resolves issues with compression, archiving, replication, Hyper-V restores, VMware schedules, and NDMP protection. For details, see the Customer Resolved Defects document.

Release 8.2.0-7

The 8.2.0-7 release resolves issues with compression and VMware backup and restore. For details, see the Customer Resolved Defects document.

Release 8.2.0-6

The 8.2.0-6 release resolves an issue with LZ4 compression of synthetic backups. For details, see the Customer Resolved Defects document.

Release 8.2.0-5

The 8.2.0-5 release resolves issues with Windows agent push, recovery of encrypted VMware and Hyper-V backups, purging, and appliance updates. For a list of defects that have been addressed in this release, see the Customer Resolved Defects document.



Release 8.2.0-4

The 8.2.0-4 release delivers new enterprise-level capabilities and performance enhancements. These features are described in this document. For a list of defects that have been addressed in this release, see the Customer Resolved Defects document.

Complete vSphere 6 protection.

Release 8.2 extends VMware protection to support VMware features introduced with vSphere 6, including hypervisor protection for Virtual Volumes (VVols) and hardware version 11 VMs. UEB on VMware appliance VMs running release 8.2 can also be upgraded to hardware version 11.

Notes:

- Hypervisor protection of ESX 4.x environments is not supported in Unitrends version 8.2. For details, see KB 3703.
- Protection of fault-tolerant VMs is not yet supported but will be in a future Unitrends release.
- If a vCenter 6 VM migrates to a different vCenter, that VM is no longer protected on the original Unitrends schedule. You must manually add it to a new schedule to resume protection.
- HotAdd support for VSphere 5.5 and 6.0.

Support for the HotAdd transport mode has been extended to UEB appliances running in vSphere 5.5 and 6.0 environments. Using HotAdd to back up datastores located on external SANs significantly increases performance.

Enhanced Windows agent push feature.

The Windows agent push feature has been enhanced to include Windows Server 2012 R2 and Windows 8.x clients. Centralized deployment of Windows agents to server and desktop clients speeds up deployment and protection of guest-level backup and recovery.

Performance enhancements for new appliances

These performance enhancements apply to S-series appliances (Recovery-nnnS models) and new UEB deployments only. These enhancements are not applicable to older appliances that are upgraded to version 8.2.

Accelerated adaptive deduplication.



Accelerated adaptive deduplication removes duplicate data before it is stored on the backup appliance, reducing the amount of landing zone space required for backups. This decreases required storage capacity and increases on-appliance retention.

For file-level backups, accelerated adaptive deduplication removes duplicate data as backups run, reducing the amount of data written to the backup appliance.

For VMware backups, accelerated adaptive deduplication removes duplicate blocks client-side, before sending data over the network to the backup appliance.

In-place synthesis.

Synthetic full backups are created from incrementals to create recovery points for faster restores. With 8.2, incrementals are synthesized in-line as backups run. This method frees critical backup appliance resources and ensures consistently fast recovery, backup, replication, and archiving times. With this method, synthetic backups are created 5-10 times faster.

Note on legacy vaulting: Beginning in 8.0, appliances use LZ4 compression by default. LZ4 is not compatible with legacy vaulting. If your appliance is a legacy vault that was imaged or deployed with version 8.0.0-4 or later, you must reconfigure compression settings by following these steps:

- 1 Select Settings > System Updates, and Licensing > General Configuration [Advanced].
- 2 Click to expand the **Disk2DiskDefaults** folder.

Select the row containing **CompressEngine**, enter *auto* in the Value field, and click **Confirm**.
